**Job Descriptions:**

1) Wargaming Internship: This internship will support Valens Global's simulations practice. Interns will help to design, build, and lead wargames, tabletop exercises, and strategic simulations. In this internship, you will have the opportunity to work beginning to end in crafting the myriad simulated worlds and scenarios that we build for our clients. One day may involve writing authentically styled intelligence memoranda and creating quirky, memorable characters; another day might have you designing imitation tweets or acting as a role player briefing one of the teams in the simulation on a hostage negotiation. Our wargames are multidisciplinary but focus on a number of relevant national-security issues, including violent non-state actors, disinformation, great power competition, new and emerging technologies, and public health. Come prepared to think systematically and engage creatively.

2) Expert Witness Testimonies Internship: The intern will conduct in-depth research and analysis on cases our organization is working on. The intern would be responsible for research and drafting early sections of an expert report. Preparing research and conclusions that can satisfy the burden of proof in a court of law is a rigorous process that will help significantly sharpen interns' research and critical thinking skills.

3) National Security Research Internship: This internship will support Valens Global's work on domestic violent extremism (DVE). The intern will conduct in-depth research and analysis on domestic extremist groups, individuals, and their activities, focusing in particular on white supremacist extremists. Activities would include analyzing DVEs' methods of fundraising and recruitment, their actions in the online sphere, and their links to transnational extremist groups. The intern will assist with network analysis and mapping of broader domestic violent extremist networks to create a comprehensive picture of the DVE ecosystem. The intern will also assist in researching policy solutions that the U.S. government and other actors (e.g., allied governments, the private sector, civil society) can enact to curb the activities of DVE groups and mitigate the threats they pose. Prior experience with network mapping and link analysis software tools, like Analyst's Notebook, are highly desirable, as are critical thinking skills and an ability to think through complex problems with nuance and an attention to detail.

### **Required Application Materials:**

In addition, please let us know which internship you are interested in (and it is okay to be interested in more than one!).
- **Resume or CV.** Let us know every job you have ever had; feel free to include volunteering opportunities too. Highlight not only your responsibilities, but also obstacles you had to overcome at each position you held.
- **Two writing samples,** preferably drawn from your university coursework. One should be brief (5 pages or less) and display the applicant's ability to convey complicated information concisely and clearly. The second sample should be longer (at least 10 pages) to showcase the applicant's ability to conduct in-depth, nuanced research. Both samples should include all relevant footnotes or citations. Neither of the writing samples should be co-authored or published.
